- iii) Graduate Senior Auditor with three years regular service.
- iv) Junior Auditors and officials holding appointments against non-account posts like Stenographers, Steno Typists and Store Keepers etc. are not eligible.
- v) The prescribed length of service should complete on 01<sup>st</sup> January, 2024.
- vi) The nominated candidates should be committed workers and their performance should also be satisfactory.
- vii) Applications may be routed only through the respective offices. No direct application will be entertained.
- viii) Nominations sent on other than the prescribed format will not be entertained.
- ix) Nominations must be according to Number of available vacancies and already PIPFA qualified officers/officials.
