The post of Deputy Director (Hajj) (BS-18) Madinah, Munawwarah, Directorate General of Haji, Jeddah, Saudi Arabia is required to be filled-in by a suitable officer through a process of selection as per prescribed policy. Job Descriptions of the post are as under: -

- To look-after the welfare of the pilgrims during their stay in Saudi Arabia

 - Service Statement (to be provided by service regulator/parent department);
 - PERs grading for the last five years (to be provided by service regulator/ parent
